First off, I want to thank everyone for choosing to be a part of BPA for the 2017 High School Season. The 2017 BPA High School season will run from June 1st, 2017 until November 1st, 2017. Please find below instructions and details of how payments will be handled. We need ALL Players to have one parent sign and return the Payment Contract, the Accident Waiver Form and the Media Release Form and give to Chris Doyle or Maia Hodge at BPA.

You may pay all fees in full or make monthly automatic bank debit/credit payments. Any special payment arrangements other than automatic bank debit/credit must be approved by Maia Hodge. PayPal is also an option, and can be done right off of the BPA website, but with this option all payments need to be turned in by the 5th of each month. If payment cannot be completed by the 5th, then please communicate that with Maia Hodge. Failure to do so could result in the player being removed from practice.

The BPA High School Team Package from June 1st, 2017 through November 1st, 2017 includes the following:

- 1) Weekly field practices
- 2) Scrimmage Games on weekends
- 3) Member's Discount on lesson packages
- 4) 15% discount on all BPA store equipment

Any tournaments and/or Showcases will be arranged by Team Managers with fees billed separately from the BPA High School Team Package.

BPA High School Team Dues: June 1st, 2017- November 1st, 2017 Financial commitment (MANDATORY):

High School Monthly Team Dues: **\$199**
Tournament Costs: **TBD & billed separately**

High School Team Dues are billed at a monthly rate of \$199 per month through auto-payment which is billed on the 1st of each month. The dates of which the automatic monthly bank debit/credit payments go through can be changed to the 15th if needed. Please talk with Maia Hodge regarding a different billing date. Tournament Fees will be billed two weeks prior to the tournament, must be paid one week prior to the tournament. Local tournaments, Showcases and out of state tournament fees are TBD and will be communicated with you as soon as BPA has the amounts. If you have confirmed to play in a tournament, and pull out within 7 days of the start of the tournament, you will forfeit your payment for that tournament unless we find a paid replacement.
